Item 9 - Other Items

As a precautionary measure in light of the recent increase in COVID-19 cases within Metro Manila, NLEX Corporation has implemented the following measures to uphold the safety and welfare of its customers and employees:

- Frontline teams e.g. toll tellers, patrol crews, and customer service personnel are required to use alcohol, hand sanitizers, and face masks when doing business with customers;
- Toll booths, meeting rooms, and patrol vehicles are disinfected before and after work shifts;
- Employees and visitors are required to undergo thermal checking before entering the NLEX offices;
- Alcohol and hand sanitizers are provided in all entrances and common areas of the workplace; and
- General sanitation via spraying / misting conducted by a third-party service provider on all NLEX and SCTEX facilities.

In support of the declaration of community quarantine guidelines within Metro Manila, we have adopted measures that will ensure continuity of service to motorists while minimizing exposure of employees.

NLEX Corporation will continue to render 24/7 expressway services to NLEX and SCTEX motorists and is ready to comply with COVID-19 management measures that may be required by relevant Government agencies.
